Conservation Practices Increase on U.S. Cultivated Cropland, Finds USDA Report

The use of no-till, crop rotations, more efficient irrigation methods and advanced technologies has climbed in recent years. That's according to a new report from USDA's Natural Resources Conservation Service on progress made through voluntary conservation over ten years. The report found significant gains for soil health and soil carbon storage while identifying areas where additional, targeted nutrient management strategies are needed. *Read the report findings in full.*

To address rising fertilizer costs exacerbated by the war in Ukraine, the U.S. Department of Agriculture plans to support independent, innovative and sustainable American fertilizer production. \$250 million dollars will be made available through a new grant program – one of many government initiatives designed to "rebuild the economy towards resilience, security, and sustainability". *Read more.*

Regenerative Agriculture Produces Healthier Crops, Study Suggests

Crops grown using regenerative agriculture practices, such as no-till farming and cover crops, have a healthier nutritional profile than conventionally-grown crops, according to new research.
